Meeting minutes

1. Next meeting

The next WG1 meeting will be 27-28 with an option for a half day meeting at the 29th May 2008 at Helsinki, Finland. The host will be Helsinki University of Technology and the local arrangement will be undertaken by Prof. H. Hämmäinen. The formal procedure

for the meeting preparations and travel reimbursement will be undertaken by Dimitris Varoutas.

2. Participating people

3. Refinement of research topics and questions

Following discussions and taking into account the participating persons, it has been decided that the new WG1 research topics will be:

- Cost and revenue modeling of internet based communication systems
- The impact of media and content on communication systems
- Demand and price dynamics and forecasts
- Business models for communications and content
- Uncertainty and risk modeling in communication business

New research questions will be included in a later phase and before next meeting

4. Horizontal actions

Dimitris Varoutas proposed that it will be beneficial for the action to have some horizontal “research joint projects” with two or more partners. Everyone agreed on this proposal and it has been decided that a first horizontal action will be undertaken by the Belgian and Greek delegates aiming to analyze the “Business aspects of municipalities’ networks”.

Communications Business and Society

Starting Point

- Originally proposed WG title: „Network Management Architectures and Economics“
- Initial topics:
 - Role modeling for provisioning IP-related and telecommunication services
 - Advanced network and service management functionality derived from new business models

DISCUSSION ON WG REPORTS 04 April and ACTIONS

Session chair: L-F Pau

The four above WG reports lead to a lively discussion, with three major issues being debated:

- a) the necessity to comply with the original COST 605 Action proposal , with four working groups ; this means in particular that the working groups must all aim *at defining one focus area representing joint interaction at WG level*; focus area to be *specified* between now and next main meeting at the end of September 2008 .This is necessary to show that interaction (although work is not funded) leads to tangible research benefits ; the case of WG1 is shown as an example
- b) the growing overlap between WG scopes and possible new titles .Instead of spending efforts on defining boundaries etc between WG, it was suggested rather to let the creative spirit prevail, provided each WG come up with a clear title (the original one or a revision) with at most 5-6 bullet focus areas, in view mostly of the COST 605 Action's external communication .Such titles and possible revised scope will be discussed at the next MC 24/9/2008. The results of the MC on this item will have to be further communicated to DC and COST ,and reflected on Web sites
- c) It was reminded that WG White papers are due Sept 1 2008 to be structured into : short background on research issues (revisited) , WG scope (eventually revised), WG focus action (specified as much as possible with deliverables), and WG results

All WG's intending to have a meeting or STSM before May 31 2008 on 2007-2008 budget were reminded to follow the applicable COST procedures , to take care of delays for approval ,and also that all proposals were subject to not exceeding the budget .

AP 1: *Each WG to define a focus area representing joint interaction, before 24/9/2008 MC .WG may decide or not to report about this at MC.*

AP2: *Each WG to finalize proposal of WG title and scope before 24/9/2008; this matter is an MC agenda item*

AP3: *Each WG to upload before Sept 1, 2008 a whitepaper as described above*
